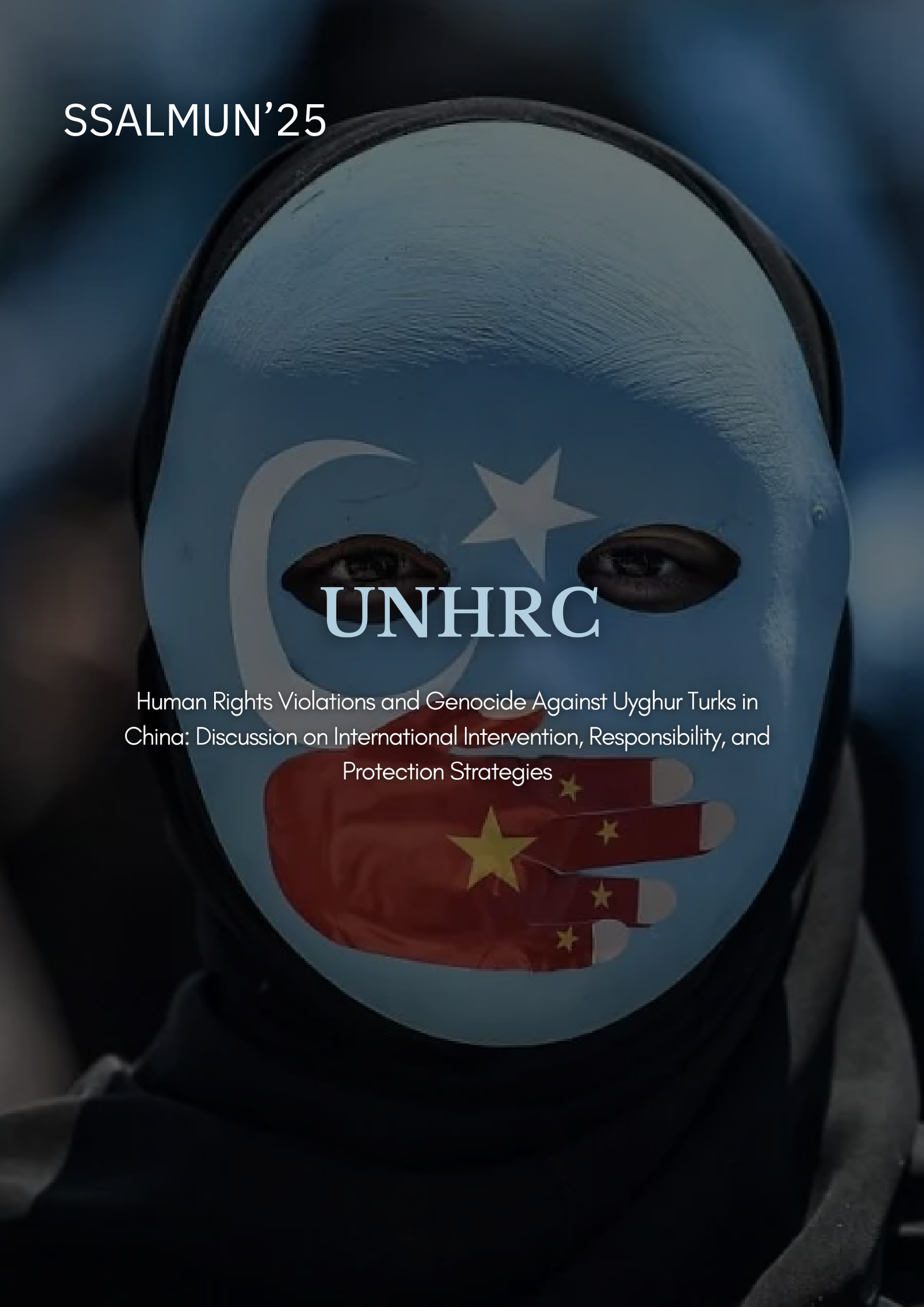

Human Rights Violations and Genocide Against Uyghur Turks in
China: Discussion on International Intervention, Responsibility, and
Protection Strategies

What is MUN ?

MUN stands for Model United Nations, which is a simulation of the United Nations (UN) where students act as diplomats representing different countries or organizations. Participants debate and discuss global issues, negotiate resolutions, and work to solve international problems in a manner similar to how the real UN operates.

In MUN, each participant is assigned a country, and they must research and represent their assigned nation's views and policies on various topics. The debates take place in committees that reflect those in the UN, such as the General Assembly (GA), Security Council (SC), Economic and Social Council (ECOSOC), and others. MUN conferences can take place at schools, universities, or as international events, and they offer students a chance to improve skills like public speaking, diplomacy, research, and teamwork while engaging with complex international issues.

Letter From Under Secretary General

Dear delegates,

I write to express grave concern over the ongoing human rights violations against the Uyghur population in Xinjiang, China, which may amount to genocide. Over one million Uyghurs have been detained in internment camps where they face forced labor, torture, and cultural suppression. Reports also detail sexual violence, forced sterilization, and the destruction of their language and religious practices.

The international community must act swiftly to hold those responsible accountable, provide support to victims, and demand immediate access for humanitarian organizations. It is our collective duty to ensure the protection of the Uyghur people and defend their fundamental rights.

I urge all Member States to unite in calling for an independent investigation, imposing targeted sanctions, and securing the release of detained Uyghurs.

This committee is tasked with examining the situation of the Uyghurs in Xinjiang, assessing the validity of the genocide allegations, and formulating appropriate international responses. Delegates will need to navigate complex issues of human

rights, state sovereignty, and geopolitical interests to develop comprehensive and effective policy recommendations.

Current situation:

The Uyghur people, a predominantly Muslim Turkic ethnic group residing in China's Xinjiang Uyghur Autonomous Region, continue to face severe human rights abuses that many international observers describe as crimes against humanity. Since 2017, reports have documented mass arbitrary detentions, forced labor, systematic sterilizations, and cultural erasure targeting Uyghurs and other Muslim minorities in the region.

In August 2022, the United Nations released a report indicating that China's actions in Xinjiang "may constitute international crimes, in particular crimes against humanity." However, frustration persists over the lack of concrete action following the UN report, with human rights groups urging for more decisive steps to hold China accountable.

Additionally, Chinese authorities have been systematically removing religious and cultural references from place names in Xinjiang, further contributing to the erosion of Uyghur identity.
